

# WETAC Report CSR 2019







## **DT SDP Program**

Wetac Stand-By International B.V. is participating in the Supplier Development Program (SDP) of Deutsche Telecom (DT). We provided DT 3 Key Suppliers to go in the SDP Journey.

EPI is the company who is responsible for this program and helping the supplier out with reaching their goals.

The program is set up to reach Best Practice in the Supply Chain. To monitor the supplier they start the following topics: Environment, Social and Governance (ESG). Schedule:

- 1. Kick-Off
- 2. Baseline Assessment
- 3. Improvement Plan
- 4. 1<sup>st</sup> Year Mid-Programme Review
- 5. DT SDP Achievement & Recognition Ceremony
- 6. Continuous Improvement
- 7. Online Assessment

At the end of the year 2019 we have one supplier in step 5 and two suppliers in the Kick-Off.

#### What we did:

- Helping the supplier out with the online assessment
- Monthly conference calls with EPI, DT and the supplier to discuss the progress
- Providing help for setting up relevant documents
- Keep an eye on the ongoing progress and support and encourage the supplier when needed

#### **Moviera**

We started with a local charity program to do something back for our local community. In 2019 we started with Moviera, a local foundation which helps the people in a domestic violence situation. They have shelters and help the people, mostly women and children, to start a new life again. We help the foundation with practical matters. We started our first project in October 2019, we provided Moviera with 100 backpacks for the children filled with school supplies.

#### **Toolbox Meetings**

We have toolbox meeting with our engineers. Also in here is CSR a regular topic we discuss because it is very near to the work they do. One toolbox was a total CSR Training.

When there is an issue happened on site we have a toolbox-meeting about the incident to discuss and to solve the problem. All the engineers have to participate. We discuss how to solve it and how to avoid it for next time. When needed, new procedures will be written.



#### **ACB Internal**

We set up an official document for our workers. We communicate this to everyone by the Buzz, the internal newsletter, and make the ACB Policy available for everyone on our servers.

We also make a risk assessment on our workers and put every person and separate also every function within the Wetac Battery Company, in a scale from Low Risk to High Risk.

## **Improvements Internal**

LED Lights warehousing
Removed all the plastic bags at BSOL in the garbage bins
Setup a recycling program for the customers and their batteries
Changed the plastic coffee cups to paper coffee cups
Filling material changed to biologic material
New, more efficient, battery chargers for the batteries of the pallet trucks

#### Issues and incidents

No major incidents or accident happened in 2019.

We had 7 small incidents in here were 4 times incidents with batteries because of carrying the wrong way. The other 3 incidents were about short circuits because of default in the tools or not enough awareness by installation. Every incident is registrated including the cause, the result, the loss of working hours (when applicable), the final conclusion and when needed and possible an improvement.

When there was an accident with one of the engineers we immediately setup a toolbox meeting to discuss what happened, how it happened and what we can do to avoid it next time.

## **Key Suppliers**

Suppliers above the € 250.000,00 purchase are categorized as key supplier. In 2019 we had 12 key suppliers. 3 of them are already in a supplier development program.



## CO2 in 2019

In 2019 we have less CO2 in comparison to 2018. This reduction is mainly caused by the reduction of flights. The CO2 per employee has increased slightly.

Emission from cars has increased, due to the fact that we have two more cars than in 2018.

Usage of gas has increased, electricity is fully renewable.

A significant saving of CO2 in the future will be to start using a renewable form of gas. With an equal usage of gas, this could result in a reduction of 60 tons of CO2. A higher cost price applies to a renewable form of gas, cost price will increase for Wetac.

At this moment we only make the calculations for our headquarter. Next step is to make the calculations also for our sales offices.
